## HEALTH AND SAFETY POLICY STATEMENT:

### INTRODUCTION

This statement sets out the policy that Southampton Aztecs FC in respect of the players, self-employees and any other person whose health and safety may be affected by activities, its intention is to set out its legal duties and moral obligations. All players have a personal responsibility for their own Health and Safety and to be aware of the impact that on other people that maybe affected.

### PREVENTION AND MANAGEMENT OF COVID

Southampton Aztecs FC is fully committed to ensure that safe COVID practices are in place to prevent any outbreak.

### STANDARDS

Southampton Aztecs FC will undertake so far as reasonably practicable the following:

- All reasonably practicable steps to ensure that all risks and hazards are identified.
- Help eliminate and minimise adverse outcomes, such as injury and damage.
- Investigation of all near misses, dangerous occurrences, and incidents.
- The provision of such information and instruction, as is necessary to ensure the health and safety of all.
- It is the responsibility of management and all personnel to do everything reasonably practicable to prevent injury and ill health.

To support our Health and Safety policy statement we are committed to the following duties:

- Undertake regular, recorded risk assessment of any premises and all activities undertaken by the Southampton Aztecs FC.
- Create a safe environment by putting health and safety measures in place as identified by the assessment.
- Ensure that all players are aware of, understand and follow Southampton Aztecs FC health and safety policy.



- Ensure that all players are aware of the emergency operating procedures that are in place and known by all.
- Provide access to adequate first aid facilities, and qualified first aider where practicable.
- Report any injuries or accidents sustained during any activity.
- Ensure that the implementation of the policy is reviewed regularly and monitored for effectiveness.

**AS A PLAYER YOU HAVE A DUTY TO:**

- Take reasonable care for your own health and safety and that of others who may be affected by what you do or not do.
- Co-operate with Southampton Aztecs FC on health and safety issues.
- Correctly use all equipment provided by Southampton Aztecs FC.
- Not interfere with or misuse anything provided for your health, safety or welfare.
